Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. 1. Scope of supply (Bid price to include all cost components): Supply Installation Testing and

- 2. Warranty period of the supplied products shall be 2 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.
- 3. **NET WORTH:** Net Worth of the OEM should be positive as per the last audited financial statement.
- 4. Buyer Added text based ATC clauses

Buyer Added text based ATC clauses:

- 1. OEM or Authorized Dealer must have 80% experience in Similar Items.
- 2. OEM or Authorized Dealer must have Service Centre in J&K (GST Certificates)
- 3. OEM must submit Green Guard & BIFMA Certificate.
- 4. OEM must submit AIOTA Certificate.
- 5. Quality management system as per International Standard 45001:2018, ISO 9001:2015, 14001:2015, ISO 50001:2011, the bidder shall furnish copy of the certificate.
- 6. OEM must have BIFMA X5.1-2017 test report for Office purpose chair.
- 7. OEM or Authorized Dealer must have minimum 100 Lacs Turnover.
